Available at Your Child's School

Extended Educational Care, EEC, is an extended day kindergarten program that allows kindergartners to remain in school for a full day.

EEC gives students the opportunity to:

- Review lessons from their regular classroom.
- Master the skills they will need to excel in elementary school.

Teachers have either a Bachelor's degree or 2-3 years direct experience.

Children who may struggle to keep up with class progress would benefit from EEC's additional instruction and reinforcement.

Children, Inc. School Age Services has been providing care for school age children since 1986.

The After School Program keeps kids' brains growing with fun and exciting learning activities in the after school hours in a safe, caring environment with specially trained, energetic staff.

Before School Care

Before School Care is a morning program designed to meet the needs of parents whose schedule requires child care before school starts. The programs run on site from 6:30am or 7:00am (depending on location) until the start of the school day. **Two day minimum per week.**

After School Care

The After School Program is held from the end of the school day until 6:00pm. Activities follow a planned curriculum and allow children to reinforce and apply what they've learned in the classroom through activities, games, projects and guests. There is time for friends, homework, snacks and physical activity. **Two day minimum per week.**

Children, Inc. also provides Extended Educational Care for half day kindergartners, as well as special programs for holidays, breaks, snow days and summer.

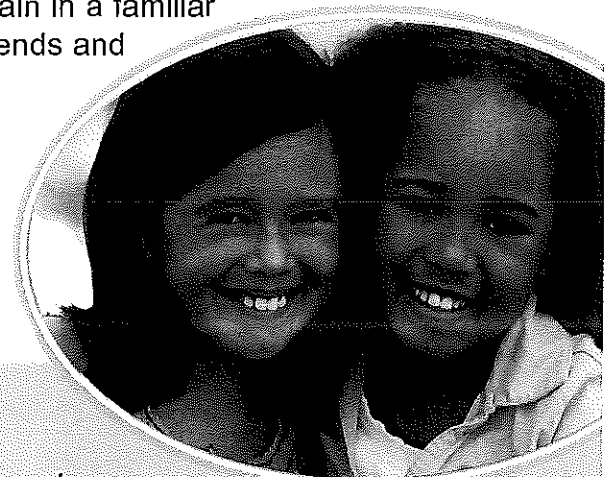
